Subject: Declaration regarding persistent chemical substances (POPS)

Dear Customer,

The Stockholm Convention of 2001 is based on the principle of precaution and aims to ensure the safe elimination of POP substances (Persistent Organic Pollutants), and to reduce their production and use.

The global treaty entered into force in 2004 and aims to ensure a high level of protection for human health given that POPs are absorbed and accumulate in the fatty tissues of biological, animal and vegetable organisms.

Persistent organic pollutants (POP) are very dangerous polluting substances. They resist degradation, bioaccumulate and are transported, through air, water and migratory species, across international boundaries and deposited far from their place of release, where they accumulate in terrestrial and aquatic ecosystems.

With regard to the Stockholm Convention and the publication on 15th July 2019 of the new POPS Regulation (EU 1021/2019), we would like to inform you that after checking the raw materials, substances, preparations and articles used in our production cycle, we can confirm that our products do not contain the 12 banned pollutants (POP).
